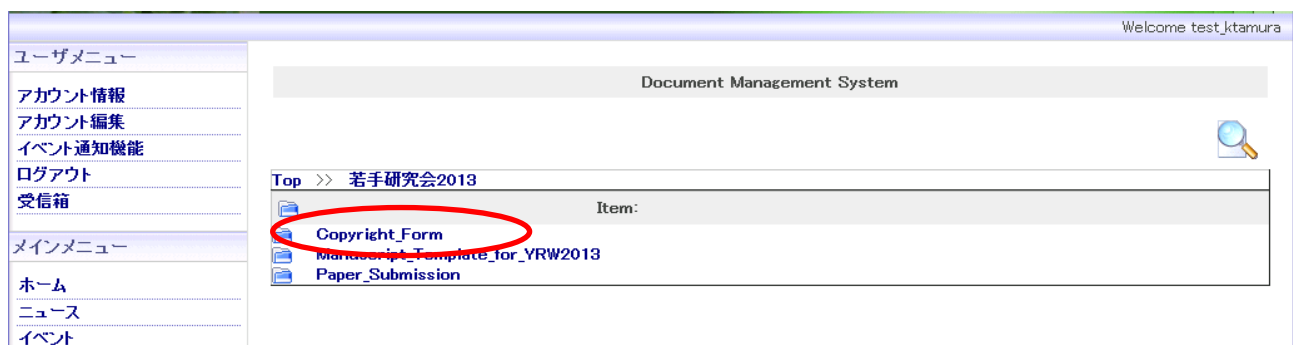

### RETAINED RIGHTS/TERMS AND CONDITIONS

#### General

1. Authors/employers retain all proprietary rights in any process, procedure, or article of manufacture described in the Work.
2.
